We provide a free lending library of books for our startup chapters.

We provide a chapter phone and business cards for our startup chapters.

We provide our startup chapters with funds to purchase their first year of liability insurance once they are incorporated.

- We've recently launched a virtual chapter to ensure that parents in Oklahoma and across the nation have an opportunity to attend a chapter meeting two times each month.

Advocacy- We advocate for the needs of the parents who attend our meetings and all parents who have children of any age who struggle with substance use disorder.
